Proof of address and ID required by the purchaser, who will be held accountable to desex the puppy. Enforced by New Zealand contract law. This is to protect the breed from unscrupulous breeders. Thank you for understanding."

Please confirm that you understand that <u>if the puppy is not desexed by its 9th month of age, the puppy must be returned to us</u> at your expense by air and you will be refunded the full amount for the puppy. We reserve the right of ownership of the puppy until it has been desexed and verified with your vet. Should we receive the puppy back in poor condition, you will also be liable for any other costs: such as vet health checks, deworming, operational procedures for lack of care for the puppy during its time in your care. This agreement will be enforced by New Zealand law.
